Dear Mr. Attorney General,

Administrative Claim, Criminal Complaint and Plea for relief

This Administrative Claim (completed Form 95 enclosed) is served to you as the “agency head” of the DOJ and legal representative for the “agency heads” of the DOJ Agencies and pendant parties posing as judges and clerks in the First Circuit Judiciary. A complaint will be filed against the United States of America pursuant to the Federal Tort Claims Act, 28 U.S.C. § 1346(b), § 1402(b), § 2401(b), and § 2671-2680 with the Judicial and DOJ officials listed below as pendant parties via 28 U.S.C. §1367. The Office of the Attorney General cannot knowingly represent a guilty party.

The hate-crimes against Complainant by the pendant parties are so extreme that the US Social Security Administration reviewed the evidence (to which no judge or DOJ agent has even acknowledged) and awarded Complainant a disability based on “judicial corruption” regarding the instant case destruction of his home/business (Addendum Exhibits 7C – But, please note Dr. Gutierrez’ determination that Complainant’s son was also kidnapped by lawyers, judges and DOJ officials, which will be the subject of future complaints). The Chief of Massachusetts General Hospital’s Mental Health Unit corroborated Social Security’s determinations and also identified “judicial malfeasance” and “judges based their rulings on a political or personal agenda rather than the facts of the case”, and extreme “derelection of duty”, professional malfeasance” and “bizarre” fraud by DOJ Agents and Democratic elected officials that continues to “prevent MGH from treating Mr. McLarnon” (Addendum Exhibit 8). **Complainant, a forensic scientist, had to go outside the Judiciary and the DOJ to have mental health professionals and scientists acknowledge our Exhibits and the overt “crimes against the US Government and treason” by attorneys, judges and DOJ officials that operate criminal enterprises in state and federal courts - and city, state and federal Democratic elected officials that benefited financially.**

Enclosed please find a Criminal Complaint and our plea for President Obama and you to help end the crimes by city, state and federal attorneys that turned President Obama and your pledge “to return to the Constitution and rule of law” and “transparency in government” into fraud upon Congress and the American people. The pendant parties received our Criminal Complaint and pleas to help end the illegal alteration of state and federal court records (Addendum Exhibits 1-5) used to usurp the judicial process. But, chose to use fraud on DOJ letterhead to cover up the alteration of court records and allow Public Safety and Public Health Issues of thirty-six (36) man-made floods in a non-flood zone to continue to use our houses as holding tanks for the city’s drainage system (See

engineer's reports in Exhibits H & I) while they, a Democratic lawyer-run commercial development scheme that plunders federal funds to overdevelop, profit financially (See Exhibit G) in RICO fashion - inciting victims to appropriate feelings of anger, betrayal, vengeance and violent revolution..

Unfortunately, we life-long Democrats are forced to include President Obama and you as pendant parties for the appointment, training and actions of the pendant DOJ officials in Executive Agencies, including Obama appointee, US Attorney Carmen Ortiz. She refused to present our Exhibits to a Grand Jury, and allowed the case attorneys, judges and court personnel to continue to operate state and federal courts as criminal enterprises where government records are altered to overthrow the Constitution by denying jury trials and civil redress in overt defiance of President Obama and your pledge to Congress and the American people. More and more citizens become victims of Bar members, judges' and DOJ officials' crimes each day – on your watch. More complaints to follow.

The Exhibits prove the Obama/Holder DOJ, including the US Marshals Service, knowingly allows attorneys, judges and clerks to usurp the judicial process by altering transcripts and dockets in state and federal courts (See Addendum Exhibits 1-4 & Exhibit A) while preventing citizens from recording hearings. US Marshals Supervising Deputy Alison Hodgkins (Addendum Exhibit 5-J) argued against Complainant's suggestion to video-record hearings with burned-in time-code, the most advanced method to document hearings as the time-code protects against alteration. Deputy Hodgkins argued for antiquated court reporters - who are forced to alter transcripts to support the judge's rulings – as revealed by this case and others the undersigned has experienced as an expert witness and forensic investigator. The Exhibits prove violations of citizens' First Amendment right "to petition government with a true and accurate record" by attorneys and judges whose crimes are protected by DOJ Agents and operate above the law.

The pendant parties posing as judges allowed floods to continue that caused the Social Security Administration to award Complainant a physical disability as a result of neck/back trauma from a fall while fighting the floods (Addendum Exhibit 7B). Yet, Malden Mayor Richard Howard claimed to the Massachusetts Inspector General "There are no floods on Hanover St." (Exhibit Q). Mayor Howard's perjury (Exhibit M) in state and federal courts and to state and federal officials is discredited by the fact that the Hanover Street Coalition has documented thirty-six (36) floods. FEMA documented a dozen. Exhibit R contains documentation of four floods since Mayor Howard's fraudulent claim (Exhibit Q) & Exhibits N&O previous floods and corroborated by Exhibits D, E, H, I, J & L. The continuing floods and the Mayor's perjury are at the center of the underlying lawsuit. The floods continue to be Public Safety and Public Health Issues (Exhibit R) for which state and federal judges have refused to provide injunctive relief.

The floods also destroyed Complainant's home/business and drove him out of business, into bankruptcy and foreclosure. Our city and state representatives are lawyers for the city and violated subpoenas ordering them to appear and testify they witnessed the city take responsibility (Exhibits D& E) illustrating an agenda of financial gain over an

allegiance to their constituents or the Constitution. Our Mayor was appointed head of Tele-COM City a project for which Rep. Ed Markey obtained federal funding and profited financially (See Exhibit G).

”Transparency” in government is betrayed by a DOJ that protects the illegal alteration of court transcripts and dockets (Addendum Exhibits 1-4), US Attorney Ortiz’ refusal to present our Exhibits to a Grand Jury, and her agenda (the Obama/Holder agenda) to allow the pendant parties and underlying case defendants to continue to alter court records to usurp the judicial process and overthrow the Constitution by ending fair tribunals, jury trials, and civil redress. See Ortiz’ letter, Addendum Exhibit 5K, and realize we asked for her response to address the Exhibits – as we did to all DOJ officials without success. Will you and President Obama address the Exhibits and corroborate the determinations of the Social Security Administration and Dr. Vindice, Mass. General Hospital’s Mental Health Unit Chief that the evidence factually proves every allegation herein?

Addendum Exhibit 5’s DOJ letters reveal DOJ officials deny any responsibility “to protect and preserve the Constitution” and claim no jurisdictional authority over the alteration of government records by attorneys and judges in state and federal courts to usurp the judicial process. Instead, the Exhibit 5’s letters prove the Obama/Holder DOJ uses fraud on agency letterhead to cover-up and protect these crimes, including the theft of Trial Exhibits (Exhibit 2). The DOJ allows the judicial process to be usurped while judges openly mock the Constitution and rule of law from the bench (See Judge Zobel’s statements in eyewitness affidavits in Addendum Exhibit 2) and mocked victims of their racketeering schemes from the bench (See Transcript for J. Zobel’s outrageous outbursts knowing she was completely unsupervised by the Judiciary and DOJ. **The pendant parties accept their salaries and agency budgets fraudulently and mock all who gave their lives to protect the Constitution, inciting appropriate feelings of anger, outrage, vengeance and violent revolution to end their tyranny and hate-crimes against American citizens.**

Since 2002 no judge or DOJ Agent has addressed the Exhibits that prove records in city, state and federal governments were illegally altered to usurp the judicial process by

Rya Zobel, her clerk Jay Johnson, civil clerks Lisa Urso, Mike Cataldo, “Jane Doe”; court reporter Catherine Handel, USDC Chief Judge Mark L Wolf, First Circuit Chief Judge Sandra Lynch, First Circuit Chief Executive Gary Wente and USDC Judge R.G. Stearns illegally altered and/or used fraud in rulings to cover up the illegal alteration of Complainant’s transcript and docket in US District Court,

Pendant parties posing as FBI officials: Director Robert Mueller, who refused to respond to our complaint, Public Corruption Unit Chief Luis Velez, Jr., Boston SAC Warren Bamford & Supervisor John T. Foley, Assistant Director Investigations Kenneth Kaiser, and Initial Processing Unit Chief Angela L. Byers,

Pendant parties posing as US Marshals: Acting Chief/Boston David Taylor, Alison Hodgkins and Director John Clark. Clark refused to respond,

Pendant parties posing as DOJ-OIG Officials: SAC Glenn Powell, SAC James E. Tomlinson, and Director Glen Fine. Fine refused to respond:

Pendant parties posing as US Attorneys/Boston: Michael Sullivan, and Carmen Ortiz. Sullivan refused to respond.

Office of Attorney General: Eric Holder, and
Executive: President Barack Obama.

Statutes of Limitation

The statutes won't start to run on any of the underlying or pendant cases until Complainant receives true and accurate city records (See Exhibits B-D) and true and accurate state and federal court records (Addendum Exhibits 1-4), denying Complainant his First Amendment right to petition government for redress of grievances with a true and accurate government record (Exhibit G & Addendum Exhibits 1-5).

Financial Loss:

The pendant parties' crimes deprived Complainant of a fair tribunal, jury trial, and true and accurate transcripts and dockets, which usurped the judicial process to deny Complainant civil redress for \$10,100,000.00 in property losses, including world-class studio equipment, inventory of original Zedz Music Production Music Library CD's, loss of sales, loss of rental equipment, loss of business income. Complainant's expert witness testified to \$1.4Million in equipment loss in one flood alone, which went unrefuted. Plus personal property losses, loss of use of finished basement, and loss of back yard. Complainant was driven out of business and into Bankruptcy. Medical costs of \$35,000.00 for dental repair, and an undisclosed amount for SSI Physical Disability and an undisclosed amount for SSI Psychological Disability (Exhibits 7&8).

This Administrative Claim satisfies the jurisdictional requirements pursuant to *McNeil v. United States*, 508 U.S. 106, 113 S.Ct. 1980 (1993); *Meridian Intern. Logistics, Inc. v. United States*, 939 F.2d 740 (9th Cir. 1991). 28 U.S.C. § 2675..

CRIMINAL COMPLAINT w/EXHIBITS (Enclosed) and plea for relief from tyranny, oppression and hate-crimes by the Obama/Holder DOJ, attorneys and judges

We ask that President Obama and you end the systemic corruption, tyranny and hate-crimes against Complainant and the other members of the Hanover Street Coalition by city, state and federal governments including, the DOJ, and the federal and Massachusetts Judiciary – or have the honesty to admit that you are members of a Bar/Judiciary that is actively overthrowing the Constitution and at war with the American people – so that open warfare can commence. Exhibit 7 reveals Complainant’s family was destroyed by “judicial corruption” regarding the state-sanctioned kidnapping of his son and the other Exhibits demonstrate his home, business, ability to walk and health have been destroyed by lawyer-run racketeering schemes overtly protected by your DOJ. Your decision on this case will prove whether your allegiance is to the Constitution or the legal industries that must be destroyed if American is to prosper. The actions of your fellow legal professionals and your very own DOJ put Complainant, President Obama and you in this situation. Your allegiance to the Violence Against Women Act is not promising as it targets and destroys the lives of innocent American men while allowing women that use false allegations to act with impunity – while lawyers plunder federal funds and are bankrupting this country. Must violence end the treason or will President Obama and you uphold your oath to the Constitution?

We ask that you order the immediate arrest and prosecution of the case defendants and pendant parties that illegally altered state and federal court records and/or covered up these crimes that usurped the judicial process to deny Complainant a fair tribunal, jury trial and civil redress and allowed thirty-six (36) man-made floods to continue by a city that uses Hanover Street houses as holding tanks (See engineer’s reports in Exhibits H & I) while using fraudulent drainage maps to plunder federal funds (Exhibits 2 & 3) for developments and their financial gain (Exhibit G).

CASE HISTORY

The underlying case of thirty-six (36) man-made floods (We are not in a flood zone) started in 1994 as City of Malden Mayor, Richard Howard (attorney), Malden Redevelopment Authority director, Stephen Wishoski, and chief engineer, John Russell, used altered city drainage system maps (Exhibit F) to plunder state and federal funds and fraudulently gain building permits to overdevelop the neighborhood of the Hanover Street Coalition (Exhibit I) of which Complainant is coordinator, causing man-made floods that are Public Health and Public Safety issues that caused Social Security disability awards (Addendum Exhibit . Malden is the hometown of US Rep. Ed Markey

and Senator John Kerry who were instrumental in bringing \$Billions in development grants of which they profited financially (See Exhibit G). Mayor Howard and Stephen Wishoski suborned corruption in state and federal courts and the DOJ, and escalated this case into a life and death struggle between Bar members and criminals posing as judges, court personnel and DOJ agents that arrogantly placed themselves between Complainant and his protected right to a fair tribunal, a jury trial, civil redress, and justice for himself and all Hanover Street Coalition members.

The floods have destroyed the coalition members houses/home businesses, including Complainant's business he ran since 1981, and drove him into bankruptcy in 2002, and foreclosure, and caused accidents that smashed out Complainant's teeth and snapped his head back causing an SSI spinal disability (Addendum Exhibit 7B). The crimes by the defendants, judges and DOJ agents detailed herein allowed the floods, which are Public Safety and Public Health issues to continue despite requests for injunctive relief since 2002. In 2009, our Mayor's fraudulent claim of "no floods on Hanover Street" (Exhibit Q) in defiance of the Massachusetts Inspector General and EPA's letter (Exhibit P) and photos of subsequent floods (Exhibits N, O & R) in 2010. City officials admitted their responsibility for causing the floods (Exhibits D-F & J); State judges and clerks admitted they conspired with the defendants' commercial development scheme; and the admission of crimes by federal judges and court personnel (Exhibit A). Yet, the Obama/Holder DOJ refused to address the Exhibits or present the Exhibits to a Grand Jury. No one has been arrested or prosecuted for sedition and treason in state and federal courts and the DOJ. And, the City of Malden continues to use the Complainant house and the other Hanover Street houses as holding tanks for the city's drainage system, which forced Complainant out of business, into bankruptcy and into foreclosure and caused physical disabilities. We repeat our request that our evidence is presented to a Grand Jury and the pendant parties prosecuted.

Despite our requests, none of the pendant parties posing as federal judges, court personnel or DOJ agents had the internal fortitude to address the facts of the case, revealing that the Judiciary and DOJ operate as Hans Christian Anderson depicted in "The Emperor's New Clothes". Specifically, their agenda (the same scam as the in "The Emperor's New Clothes") is to avoid facts and the truth in favor of a political agenda and an allegiance to lawyers and judges (and Emperors) above their constitutional oaths - just as "court members" did in the Dark Ages. Their tactics drag the DOJ and Judiciary back to Dark Ages when they had unsupervised power that created madness in overt defiance of the Constitution they swore to uphold.

Financial Motive for RICO scheme

A jury trial, civil redress and justice have been denied for ten years of litigation to cover up that City of Malden natives, Rep. Ed Markey and Senator John Kerry, brought billions of dollars of federal grants (Exhibit G) using altered city drainage maps (Exhibit F) to gain building permits and plunder federal funds for Tele-Com City to which Malden Mayor Richard Howard was appointed director and all executives "contributed" kick-backs to Ed Markey's unopposed re-election campaign (Exhibit G). Our city and state

representatives violated subpoenas to testify (Exhibit J) as they, too, benefited financially as lawyers for the publicly funded Tele-Com City project - in RICO fashion.

Your Office cannot knowingly represent guilty parties. The DOJ letters in Addendum Exhibit 5 reveal an agenda ignore the Exhibits that reveal:

- the Judicial pendant parties illegally altered US District Court docket (Addendum Exhibit 1); the six eyewitness affidavits (Addendum Exhibit 2) and contextual jumps in the Transcript (Addendum Exhibit 3) prove the transcript is illegally altered;
- the state AG and the state defendants, including judges, admitted the state actors participated in a criminal conspiracy with the Malden and Water Works defendants in state court under color of law, including they illegally altered the transcript and stole Trial Exhibits from Complainant (Exhibit B)
- the Respondents to the Affidavit of Truth (Exhibit A), two federal judges and court personnel could provide no evidence to counter the affidavit's statements of truth that detail the crimes in state and federal court;
- The Social Services Administration awarded Complainant a disability as a result of irrefutable evidence of "judicial corruption" that targeted Complainant in hate-crime fashion and destroying his life with crimes documented herein (Addendum Exhibit 7).
- Senator Ted Kennedy wrote a letter (Addendum Exhibit 5-d) acknowledging wrongdoing by the FBI for using fraud (Addendum Exhibit 5C) MGH's Mental Health Unit Chief determined was "bizarre" (Addendum Exhibit 8) on DOJ letterhead to cover up illegal alteration of transcripts and dockets in state and federal courts (Addendum Exhibits 1- 4).
- DOJ-OIG Special Agent Tom Hopkins also acknowledged wrongdoing by DOJ Agents and filed complaints to the FBI and OIG, which were covered-up via fraud by FBI and OIG revealed by their letters in Addendum Exhibit 5.

The Exhibits reveal an agenda of hate and destruction against Complainant and the other members of the Hanover Street Coalition for merely discovering the criminal activities of the case defendants and pendant parties in city, state and federal governments, including First Circuit Judiciary that are operated as criminal enterprises where judges, lawyers and court personnel illegally alter court dockets and transcripts (Addendum Exhibits 1-4; Exhibit A) to usurp the judicial process, the arrogance of which incites victims to appropriate feelings of anger, vengeance and violent revolution to end the sedition and treason documented herein that started in the City of Malden and moved to state and federal courts and DOJ Agencies the corruption of which leads directly to your Office and the Office of the President, which has escalated an issue of floods to a life and death struggle – as lawyers, judges and politicians have been unsupervised for so long they've gone mad with power and feel they can destroy any American at will.

President Obama and you called the American people "cowards" regarding race, yet the Obama/Holder DOJ is operated by pendant parties whose agenda to totally ignore the facts of this case? Will you hold the case defendants and pendant parties responsible for their "Crimes against the US Government and treason"?
